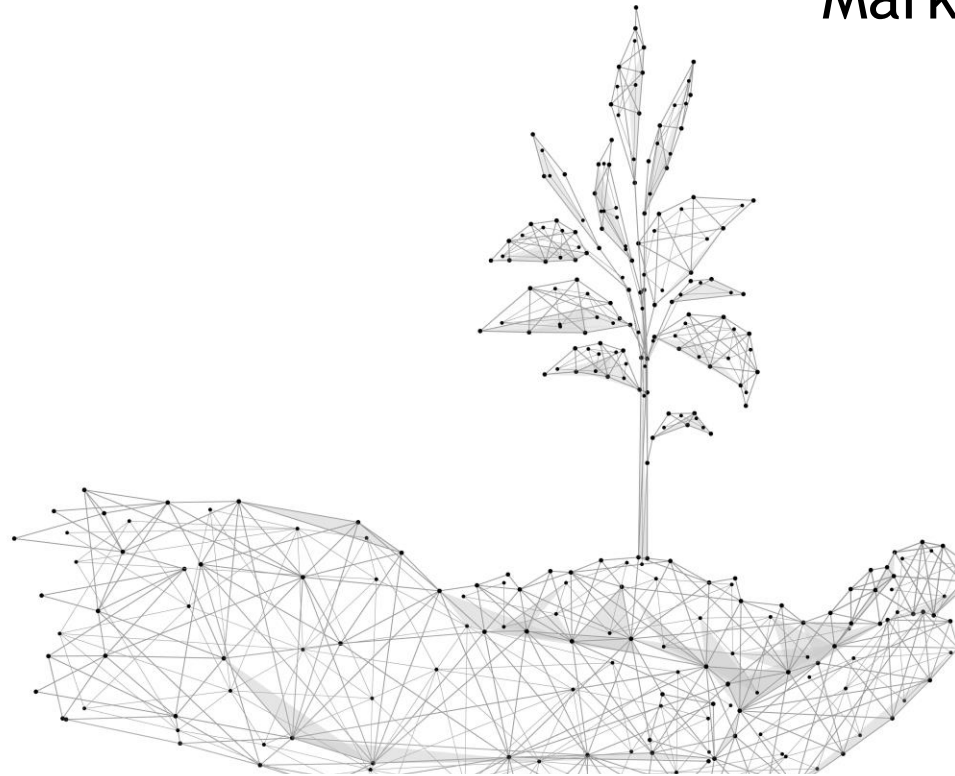

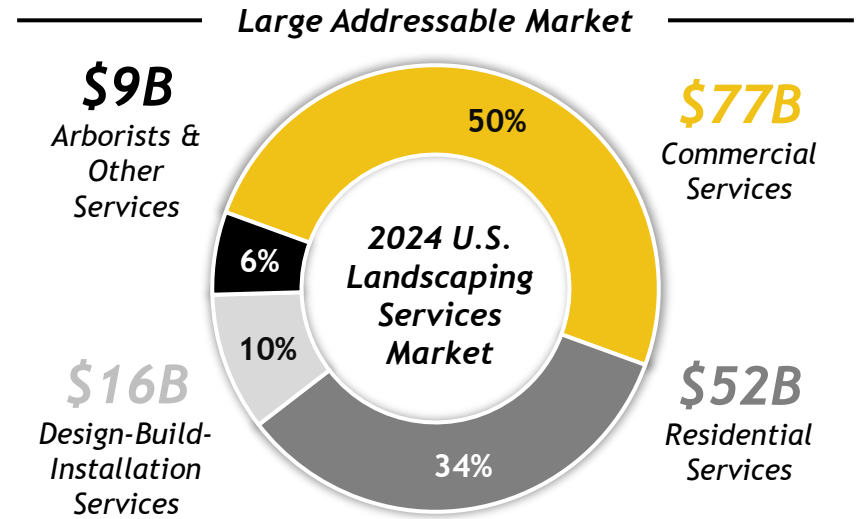

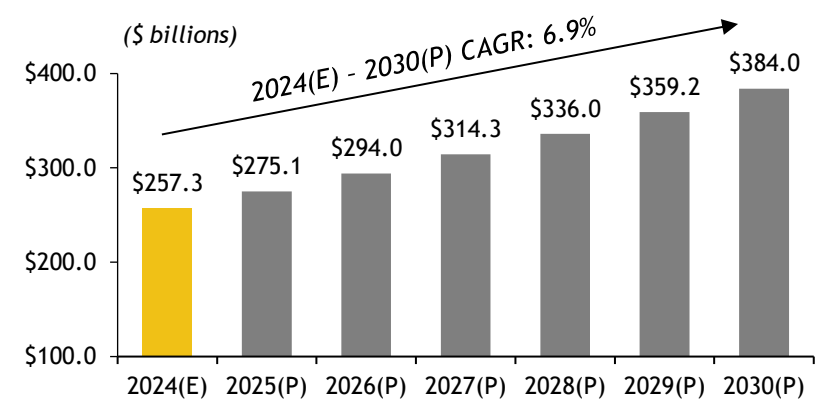
Market Overview

Landscaping Services Market Outlook

- The global landscaping services market is expected to be valued at **\$257.3 billion in 2024** and is projected to grow at a **CAGR of 6.9%**, reaching **\$384.0 billion by 2030**. Commercial landscaping services maintains the highest market share of any subsegment, accounting for ~50% of 2024 U.S. industry revenue.
- The landscaping services sector has been an attractive area of investment for private equity investors, due to several attractive characteristics:
 - Opportunities for recurring revenue streams in the form of maintenance contracts
 - Highly fragmented market where most industry players are small and lack scale
 - Legislative mandates for green spaces across commercial, residential, and government end markets
 - Demand for year-round service
- Many commercial facilities in the U.S., particularly in the tourism and hospitality industries, are trying to attract visitors by developing innovatively landscaped spaces, such as landscaped rooftops and atriums. Apartment complexes have also started to capitalize on the concept of “landscape amenities,” adding more amenities like dog parks and picnic areas to their properties.
- This trend has given a boost to the design-build-installation players and has presented commercial landscapers with opportunities for new and bigger maintenance contracts. As a result, companies with customer bases favoring commercial end markets have been particularly sought after assets in 2024.
- Strategic acquirers have also been active in the sector, pursuing M&A opportunities to expand market share, grow & retain labor, and diversify customer bases.






Global Landscaping Services Market Size



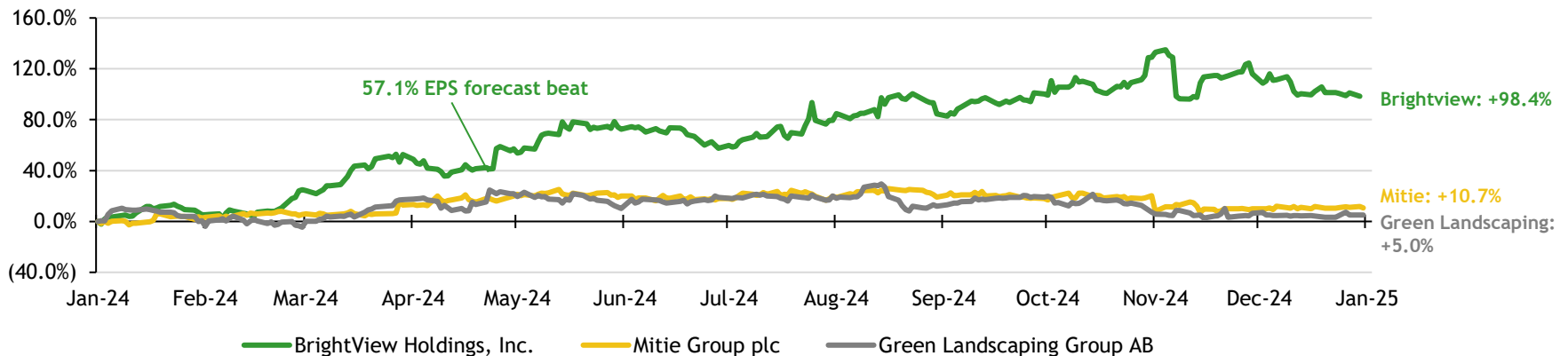

Indexed Stock Performance - LTM Jan25



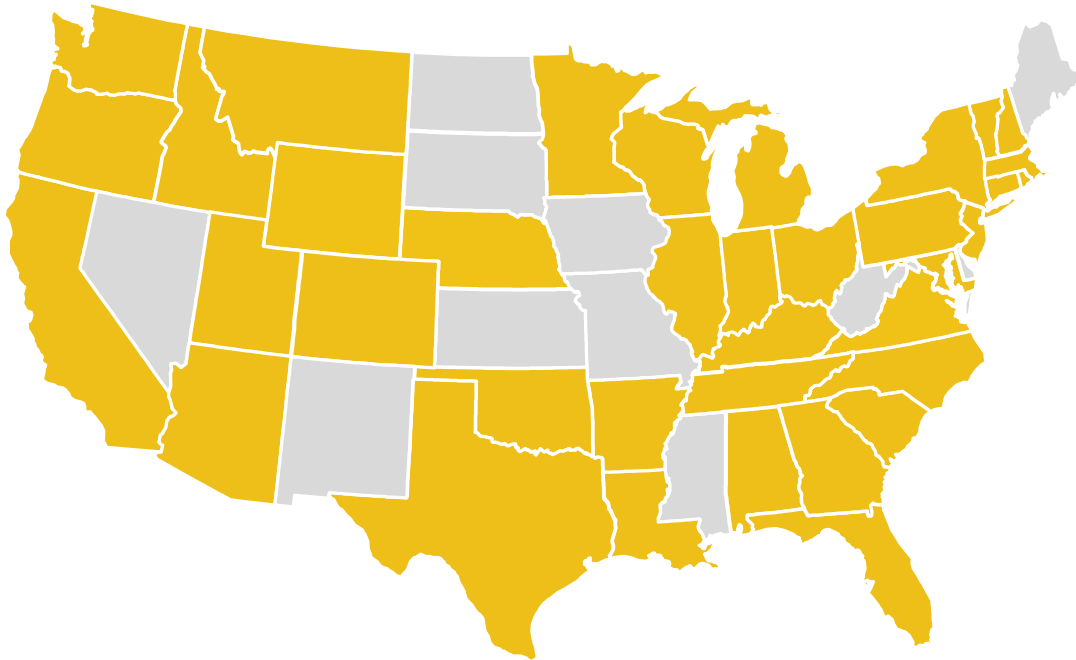

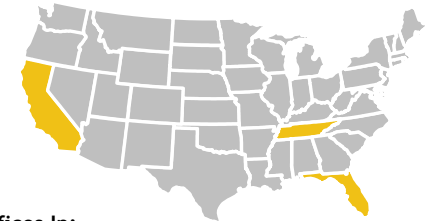
